Response to your request for official information

Thank you for your request of 1 July 2017 under the Official Information Act 1982 (the Act) for:

'The Human Rights Review Tribunal hearing for Atkinson and Others v. Ministry of Health heard that 272 disabled people had resident family members as their paid carers.

This is a very specific number, so I assume that the Ministry of health is aware of the circumstances of these arrangements.

I need to know:

1. The relationship of the resident family carer to the disabled adult.
2. The number of hours per week that resident family carer was paid for.
3. The total number of hours of support allocated to the person.
4. The mechanism whereby the payment of the family carer was facilitated, i.e, through a contracted provider, or through Individualised Funding, Contract Board or some other arrangement.

Also, the HRRT decision for Atkinson and Others v. MOH

"[156] Not surprisingly, these various sets of data provided information that was not easy to reconcile. But it was evident (and agreed by the parties) that there is a significant number of people with severe disabilities who do not receive Ministry funded disability support services – this group could total up to 29,000 in all."

5. Has the Ministry of Health managed to refine this figure (29000) in the light of the release of the data from the "Demographic Information on Clients Using the Ministry of Health's Disability Support Services as at September 2013"? (Bearing in mind that it would be bordering on irresponsible for some with a 'severe' disability to not be registered with their local NASC in the event that the unpaid family carer was suddenly unable to support that dependent person.)'

The information relating to this request is itemised below, with copies of documents attached.

In response to question five, the 29,000 figure referred to was derived from modelling in 2008 of the number of disabled people in New Zealand who could potentially be Ministry funded service users at that time. This was based on the number of New Zealanders who in the 2006 disability census self-reported being severely disabled with a long term impairment.

Because this figure was based on Statistics New Zealand data the Ministry of Health has not refined it. The number of disabled people funded by Disability Support Services (DSS) in the 2013 Demographic report is reflective only of those disabled New Zealanders who have been assessed as eligible for disability funding under DSS's eligibility criteria at that time. This number is not reflective of the total number of New Zealanders who could have been potentially eligible for Ministry of Health disability funding at the time the modelling was done.

The information relating to questions 1-4 of your request is listed in a table on the following pages. This is historic information that was initially collated in 2007¹. None of the people supported in these arrangements back then are being supported in non-compliant service arrangements now. Their names and National Health Index numbers have been withheld under section 9 (2)(a) of the Act for privacy reasons. I do not consider that the public interest outweighs my decision to withhold this information.

Please note that if no information was obtained or confirmed about a particular data category at that time, the information is not included or specified as 'not defined'. This will explain the gaps in the table provided.

I trust all this information fulfils your request. You have the right, under section 28 of the Act, to ask the Ombudsman to review my decision to withhold information under this request.
